Agency Payments... the Software

This product has been designed both as a standalone solution to cover payments to external Agencies and as a companion product to our popular Foster Care Payments package. It is designed to cover all payments for placements that are made outside the LA's own resources, typically by invoice. This would cover, but not exclusively, payments to residential establishments, schools and fostering agencies. Combine it with our Foster Care Payments, Care Leavers and Direct Payments modules and you have a single solution that covers ALL child care placement expenditure!

Agency Details

Core Details are held on the application covering the Agency/Resource. The Agency Details created in the application can be both a placement provider and a managing agency, as the package provides the facility for linking Carers etc. to the Agency record, thereby ensuring that payments are made direct to the Agency even if the service is being provided by multiple carers/resources at different locations.

Placements

Client placements are first made with the Agency and then the specific supplier with that agency. All details of standard placement charges are included in this form, including the option 'Pay on Invoice'. This gives the application the option to either pay the provider 'automatically' without an invoice or to wait for the invoice to arrive.

The placement form also handles

- One off payments for extra items
- Overpayments
- View of Payment History

Invoice Entry

As invoices for external placements are received the details are entered onto the Invoice Entry screen for that agency. As a new invoice is set up, the application automatically generates the amounts that it believes should be made. This will be a combination of weekly charges entered onto the placement and any adjustments that have been added to the care package for one-off items. The user is required to reconcile the amounts being claimed on the invoice with the details held on the application, before approving the invoice for payment.
